- Regardless of dependency status and age you **must have reported** your parent's 2020 income information on your 2022-2023 FAFSA.
- Have a valid 2022-2023 Financial aid award.
- Have unmet need.

- Completed Pharmacy Request for Additional Aid form.
- Attached to the request for additional aid, **your parents 2020 IRS Federal Income Tax Transcript** or income verification (Social security verification, certified letter from foreign country, etc.).
