The request for Health Professional loans and Loans for Disadvantaged Students will be accepted **beginning Thursday, September 18, 2024**. The **Priority deadline date for submission is October 14, 2024**.

Please note funds are limited and are awarded based on eligibility and first come first serve basis.

The following federal government guidelines are required for consideration:

- Regardless of dependency status and age you **must have reported** your parent's 2022 income information on your **2024-2025 FAFSA**.
- Have a valid 2024-2025 financial aid award on your Banner Web account.
- Have unmet need.

The following must be submitted to the facounselors@xula.edu email address as a password protected document.

- Completed Pharmacy Request for Additional Aid form.
- Attached to the Request for Additional Aid form, must be **your parents 2022 IRS Federal Income Tax Transcript** or income verification (Social security verification, certified letter from foreign country, etc.).

Reminder:

- **The team will not be able to evaluate your submission if ALL the above required documents are not submitted together. (NO EXCEPTIONS)**
